

# CAREERSOURCE CHIPOLA CONTRACT FOR SERVICES

This Contract is between CareerSource Chipola., hereinafter referred to as "CSC", whose address is 4636 Highway 90 East, Suite K, Marianna, Florida and Twin Oaks Juvenile Development, hereinafter referred to as "Service Provider", the address of which is 2930 Kerry Forrest Pkwy, Suite 101, Tallahassee, Fl. 32309, for the express purpose of provision of services pursuant to the Workforce Innovation and Opportunity Act (WIOA) of 2014, and any other programs administered by CareerSource Chipola and funded within this Contract.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and representations contained herein, the Parties hereto agree as follows:

### ARTICLE I. SCOPE OF SERVICES

The Service Provider, in a satisfactory and proper manner as determined by CSC, shall carry out all activities as agreed upon in this Contract for Services. Such activities shall be performed, except as otherwise specifically stated herein, by persons or instrumentalities solely under the dominion and control of the Service Provider. The purpose of this Contract is to provide services to in-school youth designed to improve graduation rates, employability skills, and to expose youth to employment opportunities within the region and Northwest Florida.

# ARTICLE II. PERIOD OF CONTRACT

This Contract is effective upon both parties signing and the Service Provider shall complete performance on or before June 30, 2021, unless this Contract is terminated as herein provided. In the event that the funds on which this contract is dependent are withdrawn, this contract may be terminated at CSC's option and CSC has no further liability to the Service Provider beyond that already incurred by the termination date and within the limits of unpaid funds that were not withdrawn.

## ARTICLE III. TERMS OF CONTRACT

The total amount of funds in this Contract is \$200,000. It is understood that these funds will be used to provide a variety of services to in-school youth that permanently reside within the five counties served by CSC.

## ARTICLE IV. INDEMNIFICATION

The Service Provider is an independent Service Provider and shall carry out and execute

its duties and responsibilities under this Contract as an independent Service Provider. In discharging such duties and responsibilities, Service Provider shall exercise due and responsible care and shall comply with all assurances contained herein. The Service Provider agrees to defend, indemnify, and hold CSC, its officers, agents, and employees harmless and blameless from liability of any kind whatsoever, including costs, reasonable attorney's fees, and expenses which arise out of, or are the result of performance or non-performance of this Contract and any claim whatsoever arising out of the contractual relationship.

One hundred percent (100%) of funds in this contract will be financed with federal funds. The total federal funds used in this contract is \$200,000. No non-federal funds will be provided by CareerSource Chipola through this contract.

## ARTICLE VI. PAYMENT & PERFORMANCE

This is a cost reimbursement contract with a fixed unit performance-based component. All performance should be completed, and invoices submitted to CSC by June 30, 2020. The amount listed for each item reflects the amount that will be made available for reimbursement upon approval of items submitted for cost reimbursement. The maximum amount to be reimbursed through this contract shall be the lessor of the amount earned by deliverable performance or \$200,000. Regardless of the amount of funds earned through deliverables the total amount payable to the Service Provider shall not exceed \$200,000 and payments are only to be made as reimbursement for actual expenditures approved by CSC.

Reimbursement payments shall be made only for items listed in the budget as presented in "Attachment A" upon submission of proper documentation as required by CareerSource Chipola.

 <u>Recruitment and Eligibility</u>: The Project Manager and County Coordinators will provide CSC with completed eligibility packages developed by CSC for at least 50 youth per county served under this contract. Enrollment in the program will not be used to determine payment for this deliverable. Each packet submitted that meets the initial eligibility criteria that students attend high school in the region will meet the criteria for this service deliverable. Eligibility packets will be provided by CSC.

- a. Deliverable: Completed enrollment packets delivered to CSC.
- b. <u>Deliverable Value</u>: \$100 per packet determined completed by CSC for up to 50 packets per county served for Calhoun, Jackson, and Liberty Counties and 25 packets per county for Holmes and Washington Counties. Maximum value \$20,000.
- c. <u>Program</u>: Service Provider will implement a recruitment and retention strategy aimed at attracting at least 200 eligible and enrolled youth to participate in the program. The project staff will work with the administrative staff at the targeted high schools in the region.
- d. Frequency of Service: On-going

<u>Enrollment:</u> Upon approval of eligibility by CSC, Service Provider will submit signed enrollment forms that will serve as Acceptance by Service Provider of individuals deemed eligible by CSC for services.

- e. <u>Deliverable:</u> Signed acceptance form submitted by Service Provider to accept individuals deemed eligible by CSC for inclusion in services to be provided through this agreement.
- f. <u>Deliverable Value:</u> Upon acceptance of students deemed eligible by CSC for each of the counties to be served at total \$200 per student shall be made available for expenditure reimbursement to the Service Provider. A maximum of \$40,000 shall be available for expenditure reimbursement for this deliverable.
- g. <u>Program</u>: Upon enrollment each participant will have a student case file created as part of our Targeted Outreach Program. The Targeted Outreach model includes eight actions steps: 1) Student Assessment; 2.) Orientation;
   3) Evaluation; 4) Support Services; 5) Community Mobilization; 6) Recruitment; 7) Mentoring; and 8) Case Management.
- h. <u>Frequency</u>: On-going, but a minimum of 200 participants must be enrolled by March 10, 2021. Failure to enroll required participants will result in funding being decreased in an amount equal to the percentage of enrolled below the required number. At least 50 participants per county must be enrolled in Calhoun, Jackson, and Liberty County. At least 25 participants per county must be enrolled in Holmes and Washington County.
- <u>Tutoring and Study Skills</u>: Service Provider will provide tutoring services for youth enrolled in the program. Service Provider will provide CSC with records tracking total hours of tutoring provided to students.
  - a. Deliverable: Monthly reports showing total hours of tutoring provided by

- student and by county for a minimum of 30 2-hour sessions per month.
- b. <u>Deliverable Value:</u> \$5,000 per report. Maximum value \$35,000 subject to funding availability.
- c. <u>Program</u>: Service Provider will implement the Project Learn program. Project Learn provides academic remediation, enrichment, and support to students. Service Provider staff will work to develop individual student plans that will identify student needs and gaps in learning. Based on the student plan, program participants will be paired with program staff, volunteers, and student mentors to help improve academic performance.
- d. <u>Frequency</u>: Service Provider will offer Project Learn Monday through Thursday each month for a minimum of 15 days per month.
- 3. Work Experience: At least thirty percent of all funds will be spent on work experience activities approved by CSC of which no more than half of the required amount can be expended on staff salaries and related benefits. Funds spent beyond the 30% requirement are not subject to the staff salaries and related benefits restriction. Funds provided by CSC will not be used to pay wages, stipends, or other training expenses for students working on state or federally funded contracted services funded through other sources.
  - a. <u>Deliverable</u>: Monthly reports on all work experience activities that detail student participation, funds earned per student, type(s) of activity qualified as work experience by student.
  - b. <u>Deliverable Value</u>: A minimum of \$30,000 must be earned by reimbursement to participants. A minimum of \$60,000, including reimbursements to participants, must be earned through work experience. Funds are earned towards deliverables based upon actual expenditures. Service Provider will submit monthly attendance forms documenting student participation and payments to students. The maximum amount available to be earned through this deliverable is \$90,000.
  - c. <u>Program</u>: Service Provider will implement the Career Launch program. This curriculum-based program introduces young people to the world of work and provides the tools they need to prepare for future careers. The primary lessons of the program focus on career exploration and matching, skills development, and work-based learning experiences. Upon completion of the curriculum-based lessons youth will be referred out for work experience through both in-house programs and partnerships with local businesses. Service Provider will also provide virtual work experiences for youth who cannot attend face-to-face sessions
  - d. Frequency: On-going
- 4. <u>Support Services and Incentives:</u> Youth will be eligible to receive supportive services and incentive payments that utilize CSC funding. Funds will be reimbursed

to Service Provider for CSC prior approved supportive services/incentive payments meeting the CSC policy requirements. The total supportive services/incentive payments available under the contract shall be no less than \$7,500. The upper limit is subject to funding availability and approval of CSC.

- a. <u>Deliverable</u>: Monthly reports detailing support services and incentives paid to youth, record of prior approval for service delivery.
- b. <u>Value</u>: Funds spent on Supportive Services shall be reimbursed as approved by CSC. Maximum amount to be reimbursed is subject to funding availability.
- c. <u>Program</u>: Service Provider will implement Club Service, a program that allows youth to earn a small educational incentive for completing workforce experience programming, participating in community service, volunteering, and club workforce education programming. Youth hours will be logged by the county coordinator and a stipend will be awarded based on the number of hours of participation. Youth can earn between \$50 and \$300/month based on a scale of hours completed. Incentives will be paid based on minimum wage and will be paid monthly. Students must complete the Job Ready program prior to participation in Club Service.
  - Service Provider will also use CSC funding to help in providing youth in need of support services as defined in accordance with WIOA sec. 3(59), services that enable an individual to participate in WIOA activities.
- d. Frequency: On-going.
- 5. <u>Financial Literacy Skills:</u> At least 100 youth will complete the Financial Literacy Skills component as described in the ITN response provided by the Service Provider
  - a. <u>Deliverable</u>: Monthly Completion Report.
  - b. <u>Value</u>: \$100 per completed certification. Maximum amount to be made available for expenditure reimbursement is \$20,000 subject to funding availability.
  - c. <u>Program</u>: Service Provider will provide The Money Matters curriculum which was designed to increase the financial literacy skills of club teens. The program aims to provide financial education through the club experience while unleashing the full potential of teens to become productive, caring, responsible citizens. Money Matters will equip teens with the decision-making skills to put them on the path to financial well-being and lifelong success.
  - d. <u>Frequency</u>: The Money Matters curriculum will be taught for 6 sessions each nine weeks. The program will have no less than 100 of the program youth complete the Money Matters program. Service Provider will invite local banks, financial, and tax professionals to come in as guest speakers to talk with youth about the importance of managing money, credit, and debt. Successful completion will have youth attend a minimum of 4-6 sessions and pass a post-test developed by Service Provider. Service Provider will also

make Money Matters available via virtual programming for teens that cannot attend sessions.

- 6. <u>Soft Skills Training:</u> Soft skills training will be made available to all youth served by funds through this contract. Youth will receive training in punctuality, work ethic, customer service, and other skills related to employability using tools, curriculum, and materials approved by CSC.
  - a. Deliverable:
    - i. Approval of tools, curriculum, and materials by CSC
    - ii. Documentation of training completions on all youth that complete training requirements as established.
  - b. <u>Value</u>: \$200 per youth participant with documented completion of training. Maximum amount to be made available for expenditure reimbursement is \$20.000.
  - c. <u>Program:</u> Service Provider will provide soft skills training as a part of all activities funded through this contract. The Service Provider will work with CSC to develop a program that allows the training to be provided outside classroom settings and in an environment that ingrains the training into other activities. The Service Provider will also include dedicated soft skills training as a stand-alone activity using an approved curriculum and materials.
  - d. Frequency: On-going.

# Required Items:

## **ARTICLE VII. AUDITS**

a. Non-Profit, Governmental and Education Entities

If this award is made to a non-profit, governmental or institution of higher education, and if this Service Provider receives \$750,000 or more in a fiscal year in federal financial assistance to operate a federal program, the federal cost principles and audit requirements of 2 CFR 200 shall be adhered to. The Service Provider shall provide for a program specific independent financial and compliance audit conducted and prepared in accordance with generally accepted government auditing standards.

b. Commercial Organizations

If this award is made to a for-profit commercial organization, and if this Service Provider receives \$750,000 or more in a fiscal year in federal financial assistance to operate a federal program, the Service Provider shall provide for a Single Audit or program specific independent financial and compliance audit conducted and prepared in accordance with generally accepted government auditing standards.

c. Audit and Monitoring Reports

- 1) Service Provider shall submit a copy of their independent audit report within thirty (30) calendar days after its receipt and not later than nine (9) months after the end date of this Contract.
- 2) If an official audit or monitoring report identifies unacceptable accounting practices and/or records management, CSC reserves the right to withhold any or all reimbursement from the Service Provider until such time as the accounting practices and/or records management are improved to the satisfaction of CSC.
- 3) The Service Provider will implement a system for monitoring fiscal, participant, and program activities for compliance with this Contract. The Service Provider will maintain documentation to verify completion of monitoring activities.
- 4) The Service Provider will respond in writing to monitoring reports and requests for corrective action plans in the allotted timeframe after receipt of the monitoring report from CSC.

## ARTICLE VIII. RECORD KEEPING

The Service Provider will be responsible for maintaining all financial records, supporting documenting and any other documents (including electronic storage media) pertinent to this contract for a period of three (3) years from the date of the final payment of this Contract, or until all audits are complete and findings on all claims have finally been resolved, whichever is longer.

The Service Provider will cooperate with CSC to facilitate the duplication and/or transfer of any said records or documents during the required retention period. If the Service Provider is unable to retain the records for the required period, the Service Provider will notify CSC in writing and request instruction. The Service Provider shall not dispose of any records without the prior written consent of CSC.

# ARTICLE IX. MODIFICATION, AMENDMENT, TERMINATION OF CONTRACT

- A. This Contract may not be modified, amended, canceled, extended, or assigned orally without the express written consent of the CSC board or Executive Director of CSC. All modifications, amendments, cancellations, extensions, or assignments must be reduced to writing and incorporated into an amendment hereto.
- B. This Contract is subject to termination by CSC on thirty (30) days advance notice to the Service Provider at its address as hereinabove specified.
- C. <u>Termination for Lack of Funds:</u> In the event funds to finance this Contract are reduced, suspended, or terminated in whole or in part, the obligation of each party hereunder may be terminated upon no less than twenty-four hours' notice in writing by CSC to the Service Provider.
- D. <u>Termination for Breach:</u> Either party may terminate this Contract when it has determined that the other party has failed to provide any of the services

specified herein in a timely or proper fashion or has violated any stipulations of this Contract. If the Service Provider fails to perform, in whole or in part, or to make sufficient progress so as to endanger performance, CSC will notify the Service Provider of such unsatisfactory performance in writing. The Service Provider has thirty (30) working days from receipt of notice in which to respond with a plan agreeable to CSC to correct said deficiencies. Upon failure of Service Provider to respond within the appointed time or failure of Service Provider to respond with appropriate plans, CSC will serve a termination notice that shall become effective within fifteen (15) days after its issuance.

In the event of such termination, CSC shall be liable for payment only for services rendered prior to the effective date of termination. Final billing for payment must be received by CSC within thirty (30) days of the termination date.

The Service Provider shall give CSC written notice of any perceived breach and it shall give CSC thirty (30) working days to cure any perceived breach under this Contract.

- E. <u>Termination for Convenience:</u> Performance under this Contract may be terminated by either party for convenience when it is in their best interest. Any termination for convenience will be preceded by written notice setting forth the effective date of said termination. The termination shall be effective ninety (90) days after the notice is issued and the Service Provider has ninety (90) days after the effective date to bill for payment. The Service Provider shall be entitled to receive just and equitable compensation for any services performed hereunder through the date of termination or suspension.
- F. <u>Termination (Other):</u> Unearned payment under this Contract may be suspended or the Contract terminated upon the refusal by the Service Provider to accept or comply with any conditions that may be imposed by the United States Department of Labor, the Florida Department of Economic Opportunity, CareerSource Florida, the Governor, or CSC at any time.

The submittal of false information may be considered fraud and could result in the immediate termination of the Contract.

This Contract shall be interpreted under the laws of the State of Florida.

G. CSC may extend the terms of this Contract by written notice to the Service Provider. CSC shall give the Service Provider a preliminary written notice of its intent to extend at least sixty (60) days before the Contract expires. The preliminary notice does not commit CSC to an extension. The Service Provider may decline an extension by providing written notification within five business days of the decision to extend being delivered by CSC to the Service Provider.

If CSC exercises this option, the extended Contract shall be considered to include this

option provision. The Contract may be renewed on a yearly basis for a period of up to tw (2) years after the initial Contract specifying the terms under which the cost may change a determined in the ITN. Renewal shall be contingent upon satisfactory performance evaluations and the availability of funds. The total duration of this Contract, including the exercise of any options under this clause, shall not exceed three (3) years.

# Certification Regarding Drug-Free Workplace Requirements

- The Service Provider assures that all activities under this Contract shall be conducted in conformance with the Workforce Innovation and Opportunity Act (WIOA), the Workforce Innovation Act of 2000 (Title XXI Chapter 445, Florida Law) and subsequent amendments, 45 CFR 98, the Temporary Assistance for Needy Families Program (TANF), 45 CFR parts 260-265, and other applicable federal regulations and policies promulgated thereunder; all applicable Federal, State and local laws, regulations, directives, policies and instructions as they pertain to this Contract which are in effect at the inception of this Contract or as may be promulgated or amended during its life; and other laws, ordinances, regulations and licensing requirements including state and federal safety, health, and personal protective equipment requirements. When determining applicability, all programs and activities funded, or otherwise financially assisted, in whole or part, under the Welfare Transition Program are considered to be programs and activities receiving federal financial assistance.
- 2. The Service Provider shall be liable to CSC for any unauthorized costs expended in the operation of the program and for any disallowed costs incurred as a result of the Service Provider expending funds not authorized under this Contract or in violation of the appropriate Federal or State statutes, regulations or guidelines. Any funds requested for reimbursement by the Service Provider which are determined by CSC, the Governor or CareerSource Florida to be in violation of appropriate Federal and State statutes, regulations or guidelines shall be refunded and repaid to CSC by the Service Provider. If this Contract or Amendments thereto are still in effect, these monies shall be withheld by CSC from any allowable reimbursement request of the Service Provider.

The Service Provider agrees to promptly repay CSC any amount previously paid to the Service Provider by CSC that is determined by final audit to be an unallowable cost or expenditure.

- The Service Provider shall maintain sufficient financial records to allow costs to be properly charged to the
  appropriate cost categories. The Service Provider shall maintain proper accounts and an accurate
  verification of participant statistics.
- 4. The Service Provider understands that modification and/or revisions to the financial and/or program aspects of this Contract may be required as a result of changes in CSC's funding allocations. The Service Provider understands and agrees that if either party desires to change or modify this Contract, the proposed changes shall be written documents executed by both parties. The Service Provider understands that the written proposed changes shall be negotiated and that the Contract shall become a written signed modification to the original Contract. The Service Provider further understands that CSC may amend the Contract to conform to those changes in any Federal or State Statute, regulation, Procedural Instruction, or Executive Order relevant to this Contract or any amendment hereto.
- 5. The Service Provider shall be responsible for implementing procedures and internal financial controls governing the management and utilization of the funds provided under this Contract. The Service Provider shall maintain its books, records and documents (including electronic storage media) in accordance with generally accepted accounting procedures and practices which sufficiently and properly reflect all revenues and expenditures of funds provided by CSC under this Contract. The Service Provider shall track costs in sufficient detail to determine compliance with applicable laws and regulations and to ensure that the funds have been lawfully spent. All expenditures must be in accordance with the applicable OMB Cost Principles. The Service Provider shall maintain separate accounting records for funds received and expended under this Contract.
- 6. All purchasing of goods and services must be in compliance with CSC procurement guidelines or the Contractor's procurement policy, if the Contractor's policy is approved in advance. Records must be maintained to document procurement efforts to comply with this requirement.

- 5. The use of contract funds to purchase equipment, as defined by 2 CFR 200, is prohibited without prior written approval of CSC. The Service Provider shall maintain an up-to-date inventory of all property purchased under this Contract. All such property shall be returned to CSC, unless otherwise authorized in writing by CSC. No such property shall be disposed of without written authorization from CSC.
- 6. The Service Provider shall establish and maintain an auditable accounting system and report on an accrual basis in accordance with recognized accounting practices and CSC's requirements for fiscal and program reports. This includes establishing record keeping systems that are sufficient to permit the preparation of reports required by the State of Florida and CSC, and to permit the tracing of funds to a level of expenditure adequate to insure that the funds have not been spent unlawfully.
- 7. The Service Provider who is a public or private non-profit agency assures that revenue in excess of costs shall be treated as program income. Accordingly, these funds may be retained by the Service Provider to underwrite additional training or training related services pursuant to the project or program that generated them. Funds not spent during the Contract period shall be returned to CSC within thirty (30) days of the expiration date of the Contract.
- 8. The Service Provider agrees to comply with OMB Circular 2 CFR 200 Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards.
- 11. The Service Provider shall implement administrative controls to identify participant training costs that are supported by other federal (DOL, Pell Grants, VA, etc.) state or local programs to ensure that costs are not being duplicated. Coordination and sharing of costs is strongly recommended. The education institutions financial aid officer is to report the specific amount and description of financial aid awarded to each WIOA participant after enrollment and this information must be documented in the participant's file.
- 12. The Service Provider assures that clarification will be sought from CSC on any policy, law, rule or regulation/directive that is not clearly understood prior to adopting any practice or procedure.
- 13. The Service Provider understands that CSC will give the Service Provider thirty (30) days to take corrective action should it be determined that there is a violation of the law. If corrective action is not taken by the Service Provider, funding will be withheld or revoked.
- 9. The Service Provider understands that evaluations of participant progress during training will be documented in a timely manner not less than monthly in the participant's file.
- 10. The Service Provider agrees that conditions of employment or training shall be appropriate and reasonable with regard to the type of work, geographical region, and skills of the participant. No participant will be trained or receive services in buildings or surroundings which are unsanitary or dangerous.
- 11. The Service Provider assures that work-based training participants will be provided the same working benefits at the same level as other employees similarly employed.
- 12. The Service Provider assures that to the extent that a State Workers' Compensation Law is applicable, workers' compensation benefits in accordance with such law shall be provided and paid for by the Service Provider. To the extent that such law is not applicable, each recipient of funds under WIOA and the Welfare Transition Program regulations shall secure insurance coverage for injuries suffered by such participants.
- 13. The Service Provider understands that CSC shall assume no liability with respect to bodily injury, illness or any other damages or losses, or with respect to any claims arising out of any activity under this Contract whether concerning persons or property in the Service Provider's organization or any third party.
- 14. The Service Provider assures that it will develop monitoring procedures to ensure that its program is in compliance with the WIOA Laws and that adequate administrative and accounting controls are being used.

- 15. The Service Provider will adhere to and comply with CSC's Complaint and Grievance Procedures, approved by the Department of Labor's Office of Civil Rights.
- 23. The Service Provider shall be liable for prosecution under the criminal provision of the 18 U.S.C.665 for theft or embezzlement of WIOA funds.
- 24. The Service Provider shall maintain the confidentiality of any information regarding CSC customers and the immediate family of any applicant or customer, that identifies or may be used to identify them and which may be obtained through application forms, interviews, tests, reports from public agencies or counselors, or any other source. The Service Provider shall not divulge such information without the written permission of the customer, except such information which is necessary as determined by CSC for purposes related to the performance or evaluation of the Contract, may be divulged to CSC or such other parties as they may designate having responsibilities under the Contract for monitoring or evaluating the services and performances under this Contract, or to governmental authorities to the extent necessary for the proper administration of the law. All releases of information shall be in accordance with applicable state laws and policies of CSC. No release of information by the Service Provider, such release is required by federal or state law, shall be construed as a breach of this Contract.
- 25. The Service Provider will comply with all applicable requirements of all other Federal laws, executive orders, regulation and policies governing these programs.
- 26. The Service Provider agrees to comply with the Veteran's Priority of Service Provisions (38 U.S.C. 425 and 20 CFR 1010).
- 27. The Service Provider agrees to comply with the Trafficking Victims Protection Act of 2000, as amended (22 U.S.C. 7104(g), 2 CFR 175).
- The Service Provider agrees that no funds under this Contract may be used in support of any religious, antireligious or political activity.
- 29. The Service Provider will comply with the Hatch Act (5 U.S.C. 1501-1508 and 7328) which limit the political activities of employees whose principal employment activities are funded in whole or in part with Federal funds.
- 30. The Service Provider will comply with requirements pertaining to copyrights (agreements which involve the use of copyrighted materials or the development of copyrightable materials) 625.420(h)(4)(i), and will comply with requirements pertaining to rights of data, 627.420(h)(4))(iii). CSC, the Department of Equal Opportunity and CareerSource Florida shall have unlimited rights to any data first produced or delivered under this Contract (Agreements which involve the use/development of computer programs/applications, or the maintenance of databases or other computer data processing programs, including the inputting of data.)
- 31. The Service Provider will comply with the Americans with Disabilities Act, (42 U.S.C., 12101 et. seq.) which prohibits discrimination by public and private entities on the basis of disability in employment, public accommodations, transportation, State and local government services and in telecommunications.
- 32. The Service Provider will comply, as applicable, with the provisions of the Davis-Bacon Act as amended (40 U.S.C. 276a-7) and as supplemented by Department of Labor (DOL) regulations 29 CFR Part 5, the Copeland Anti-Kickback Act (40 U.S.C. 276c and 18 U.S.C. 874) as supplemented by DOL regulations 29 CFR Part 3, and the Contract Work Hours and Safety Standards Act (40 U.S.C. 327-333) as supplemented by DOL regulations 29 CFR Part 5, regarding labor standards for federally assisted construction subagreements.
- 33. When applicable, if this Contract is in excess of \$100,000, the Service Provider shall comply with all applicable standards, orders or regulations issued under the Clean Air Act as amended (42 U.S.C. 7401 7671g) and the Federal Water Pollution Control Act (33 U.S.C. 1251-1387), as amended. Any violation of

these Acts should be reported to CSC and the Regional Office of the Environmental Protection Agency (EPA).

- 34. The Service Provider understands it is illegal for any corporate entity to punish whistleblowers or retaliate against any employee who reports suspected cases of fraud or abuse (Sarbanes Oxley, Section 1107, Section 1513 of Title 18, USC). In addition, it is a crime to alter, cover up or falsify, or destroy any document that may be relevant to any official investigation (Sarbanes Oxley, Section 1102, Section 1512 of Title 18, USC).
- 35. In compliance with WIOA Public Law 113-128, Section 194 (15) none of the funds provided under this title shall be used by a recipient or sub-recipient of those funds to pay the salary and bonuses of an individual at a rate in excess of Executive Level II. This restriction does not apply to vendors/contractors providing goods and services as described in NPRM 683-290(c).
- 36. The Service Provider shall comply with mandatory standards and policies relating to energy efficiency which are contained in the State of Florida's energy conservation plan issued in compliance with the Energy Policy and Conservation Act, Pub. L. 94-163.
- 37. A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services, may not submit bids on leases of real property, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a CSC contract for a period of thirty-six (36) months following the date of being placed on the convicted vendor list.
- 38. The Service Provider shall fully comply with nondiscrimination and equal opportunity laws, Section 188 of the Workforce Innovation and Opportunity Act of 2014 (WIOA), which prohibits discrimination against all individuals in the United States on the basis of race, creed, color, religion, sex, national origin, age, disability, political affiliation or belief, and against beneficiaries on the basis of either citizenship/status as a lawfully admitted immigrant authorized to work in the United States or participation in any WIOA Title I financially assisted program or activity and the Service Provider agrees that it shall comply with Executive Order (EO) No. 11246, Equal Employment Opportunity, as amended by EO No. 11375, and as supplemented in Department of Labor regulation 29 CFR parts 33 and 37 as well as 41 CFR part 60 and 45 CFR part 80, if applicable, including the Nontraditional Employment for Women Act of 1991; Title VI of the Civil Rights Act of 1964, as amended; Section 504 of the Rehabilitation Act of 1973, as amended; the Age Discrimination Act of 1975, as amended; Title IX of the Education Amendments of 1972, as amended; Section 654 of the Omnibus Reconciliation Act of 1981, as amended; and with all applicable requirements imposed by or pursuant to regulations implementing those laws.

The Service Provider further agrees that it will in no way discriminate against, deny benefits to, deny employment to, or exclude from participation any person on the basis of race, color, religion, sex (including pregnancy), sexual orientation, gender identity, gender expression, sex stereotyping, national origin, age, disability, marital status (except as otherwise permitted under Title IX of the Education Amendments of 1972), political affiliation or belief, citizenship status as a lawfully admitted immigrant authorized to work in the United States, from any program or activity funded in whole or in part with funds made available through CareerSource Chipola. It is also agreed that participation in programs and activities shall be open to citizens and nationals of the United States, lawfully admitted permanent resident aliens, refugees and parolees, and other individuals authorized by the Attorney General to work in the United States. It is further agreed that the grievance and complaint procedures submitted by the grant recipient and approved by the Office of Civil Rights will be adhered to.

Programs funded through CareerSource Chipola are equal opportunity programs and the Service Provider shall assure that all programs and activities conducted under this Agreement are accessible to individuals with disabilities. Where the physical facilities are not accessible, an alternate plan for accessing the program or activity must be developed and retained on file, and a copy provided to the CareerSource Chipola Equal Opportunity Officer. Provisions must also be made for the limited English speaking and

vision and sensory impaired. These provisions include: having a plan to provide interpreters and sign language assistance when necessary, and assuring that adequate staff or other sources are available to adequately communicate with non-English speaking applicants and/or participants.

CareerSource Chipola has established and maintains procedures to informally resolve grievances or complaints from, and provide counseling to participants in programs operated under this Agreement. A representative of the Service Provider will be required to inform program participants of such procedures and their right to file with the appropriate local, State, or National entity a complaint if the matter is not resolved through informal procedures. The Service Provider agrees to require that each participant read and understand their rights and responsibilities as enumerated in the Notice of Nondiscrimination and Complaint and Grievance Procedures Form.

Sub-recipients shall not discharge or in any manner discriminate against any individual in connection with the administration of the program, or against any individual because such individual has filed any complaint or instituted or caused to be instituted any proceeding under or related to this Act, or has testified or is about to testify in any such proceeding or investigation under or related to the Act, or otherwise unlawfully deny to any individual any benefit to which that participant is entitled under the provisions of the Act or privileges secured by 29 CFR Part 34.

- 39. The Service Provider shall not employ an unauthorized alien. The employment of unauthorized aliens is a violation of the Immigration and Nationality Act (8 USC 1324 a) and the Immigration Reform and Control Act of 1986 (8 USC 1101). Such violation shall be cause for unilateral cancellation of the Contract by the Board as specified in the Contract.
- 40. If the Contract contains federal funds and the Service Provider provides services to children up to age 18, the Service Provider shall comply with the Pro-Children Act of 1994 (20 USC 6081). The Service Provider shall immediately report knowledge or reasonable suspicion of abuse, neglect, or exploitation of a child, aged person, or disabled adult to the Florida Abuse Hotline on the statewide toll-free telephone number (1-800-96ABUSE). As required by Chapters 39 and 415, F.S., this provision is binding upon the Service Provider and its employees.
- 41. The Service Provider and any of its subcontractors shall comply with applicable Federal, State and local Child Labor Laws.
- 42. Contracts or agreements for the performance of experimental, developmental or research work shall provide for the rights of the Federal Government and the recipient in any resulting invention in accordance with 37 CFR part 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by the awarding agency.
- 43. Contract Work Hours and Safety Standards Act (40 U.S.C. 3701-3708) Where applicable, all contracts awarded by the non-Federal entity in excess of \$100,000 that involve the employment of mechanics or laborers must include a provision for compliance with 40 U.S.C. 3702 and 3704, as supplemented by the Department of Labor regulations (29 CFR Part 5). Under 40 U.S.C. 3702 of the Act, each Service Provider must be required to compute the wages of every mechanic and laborer on the basis of a standard work week of 40 hours. Work in excess of the standard work week is permissible provided that the worker is compensated at a rate of not less than one and a half times the basic rate of pay for all hours worked in excess of 40 hours in the work week. No member of any Board of Directors under the WT Program/TANF or WIOA shall cast a vote on the provision of services by that member or any organization that the member directly represents or vote on any matter, which would provide direct financial benefit to that member.

- 45. The failure of CSC to strictly enforce any of the provisions of this Contract, or require strict performance by the Service Provider of any of the provisions herein, shall in no way be construed to be a waiver of such provisions or any other validity of this Contract or any part hereof, or waive the right of CSC to enforce each and every provision here.
- 46. The Service Provider understands that CSC has the right to terminate this Contract by written notification when an extenuating circumstance arises, for example when the work is no longer required. It is understood that the Service Provider will be compensated for work already completed or in the process according to accurate appropriately submitted documents.
- 47. This Contract is subject to termination by CSC with thirty (30) days advance notice in writing to the Service Provider. In the event funds to finance this Contract are not available, the obligations of each party hereunder may be terminated upon no less than twenty-four (24) hours notice in writing by CSC to the Service Provider
