CONSENT ITEM - 06/12/25 MEETING

Al Bryant made the motion, Bryan Lee seconded the motion, and the vote was unanimous to approve the minutes of the June 12, 2025, general meeting.

STATUS OF FUNDS REPORT

Richard Williams and Sara Johnson discussed the Status of Funds Report. The Board noted no issues and had no questions.

MISSION MOMENT

Niki Long presented to the board CareerSource Chipola's successful Summer Youth Program, providing a unique opportunity for career exploration to youth in the 5-county service area. Ms. Long shared that summer youth employment programs instill in the young adults of tomorrow critical essential skills that all employers need. This year, the focus was to help youth acquire the knowledge and skills they needed to become healthy and productive adults.

Many of the youth workers had their very first work experience and were able to gain some real-life soft skills, such as leadership, social skills, and time management. A total of 35 youth participants were enrolled. 21 young adults were placed at various worksites while 9 additional youth participants completed Florida Ready to Work Soft Skill and Digital Skills classroom training.

2025-2026 BUDGET

The Executive Committee met on September 17, 2025, and approved the 2025-2026 Draft Budget to be presented to the Board. The Board noted no issues. **Travis Ephriam** made the motion, Jonathan Fuqua seconded the motion, and the vote was unanimous to approve the Draft 2025-2026 Budget.

ONE-STOP OPERATOR REPORTS

TRAINING VENDOR APPLICATION APPROVAL

Penny Bryan made the motion, Keith Sutton seconded the motion, and the vote was unanimous to accept the application from North Florida Trucking Academy, Inc. as an approved training provider.

POLICY CHANGE CONSIDERATION FUNDING LIMITS

Current board local operation procedures limit funding for an individual seeking training to \$5,000 for training costs and \$2,000 for supportive services. NEW TRAINING PROGRAMS CHIPOLA COLLEGE

BOARD ACTION REQUIRED

Background

In accordance with the United States Department of Labor, Training and Employment Guidance Letter No. 8-19, Code of Federal Regulations, 680.400, and the Florida Department of Economic Opportunity's guidance, the State list of eligible training providers and programs and the related eligibility procedures ensure the accountability, quality, and labor-market relevance of programs of training services that receive funds through the Workforce Innovation and Opportunity Act (WIOA). The State and Local list of eligible training providers and programs is also a means for ensuring informed customer choice for individuals eligible for training.

CareerSource Chipola received a completed Program Description Statement of Work for four (4) programs at Chipola College: HVAC, Plumbing, Electricity, and Practical Nursing. These programs are included on the PY 2025-2026 Regional Demand Occupations List issued by FloridaCommerce.

Each of the programs are eligible for Pell assistance; therefore, multiple sources of funding will be used to support the successful completion of training.

<u>Staff Recommendation:</u> The staff recommendation is to approve these additional programs for inclusion on Chipola Colleges' list of approved training programs.

Action Item: Review and approve the training programs.

***Must have CDL A permit, driving record (last 3 years), physical/drug screen, and have paid required deposit for Commercial Driving "Complete the CJBAT, background check and physical/drug screening for Correc

Complete the background check and physical as required by the training provider/program

Must have official letter of acceptance for the training program

Per Florida Statute, there are NO tuition fees for Registered Apprenticeship participants. Only the cost of tools, books, and materials needed for the trade are to be paid.

The 2025-2026 Regional Demand Occupations List can be used as a reference for training based on local demand. Staff must seek permission from management.
